

4. DREDGING PERMIT, T&S LANDS OF PETALUMA RIVER NEAR NOVATO, MARIN COUNTY, TO DEEPEN SEWER-PLANT-DISCHARGE CHANNEL; UNION BANK OF LOS ANGELES - W.O. 7153, P.R.C. 4109.9.

After consideration of Calendar Item 36, attached, and upon motion duly made and carried, the following resolution was adopted.

THE COMMISSION AUTHORIZES THE ISSUANCE TO UNION BANK OF LOS ANGELES OF A PERMIT, EFFECTIVE DECEMBER 19, 1968, THROUGH DECEMBER 31, 1969 TO DREDGE APPROXIMATELY 4000 CUBIC YARDS OF MATERIAL FROM STATE LANDS IN THE PETALUMA RIVER, MARIN COUNTY, WITHOUT PAYMENT OF ROYALTY, SUCH LANDS BEING DESCRIBED IN EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF.

## APPLICATION FOR DREDGING PERMIT

APPLICANT: Los Angeles

DREDGE LOCATION: Petaluma River near Novato, Marin County

TYPE OF LAND: Tide and submerged

PURPOSE: To deepen an existing sewer-plant-discharge channel

## AMOUNT TO BE DREDGED:

Approximately 4000 cubic yards

## DISPOSITION OF DREDGED MATERIAL:

Within dredge area on State lands

CONSIDERATION: Public benefit

## OTHER PERTINENT INFORMATION:

1. Corps of Engineers has issued a letter of permission approving the project
2. The State agencies concerned have approved the project as follows:
  - a. The Department of Fish and Game has no objections
  - b. The Department of Water Resources has no objections
  - c. The Water Quality Control Board has requested that all dredging, stockpiling, construction, and the operation of equipment for the work described be performed so as to minimize roiling of the waters and to prevent timbers or floats that may be used in the work from drifting away as a threat to small craft. If hydraulic dredging is proposed, the applicant is requested to inform the San Francisco Bay Regional Water Quality Control Board in advance of operations.
  - d. The State Department of Parks and Recreation has made an examination of the proposed project, pursuant to Section 6818 of the Public Resources Code, and has no objections

Thence North 6° 43' 59" West 123.72 feet;

Thence leaving said line, North 61° 42' 25" East 1200.00 feet;

Thence South 28° 17' 35" East 300.00 feet;

Thence South 61° 42' 25" West 1300.72 feet to the point of beginning.
