

8. 49-YEAR PUBLIC AGENCY PERMIT, SUBMERGED LAND OF AMERICAN RIVER IN SACRAMENTO, SACRAMENTO COUNTY, INSTALLATION OF POWER LINES ATTACHED TO NEW BRIDGE; SACRAMENTO MUNICIPAL UTILITY DISTRICT - W.O. N-0295, P.R.C. 4113.9.

PUBLIC AGENCY PERMIT

APPLICANT: Sacramento Municipal Utility District

LOCATION: A 5- x 820-foot strip of submerged land across the American River at Howe Avenue, Sacramento, County of Sacramento

PROPOSED USE: The installation of power lines encased in conduit and attached to a new bridge

TERM: ~~49 years, from April 1, 1968~~

CONSIDERATION: No charge, pursuant to Sections 10151 and 12808 of the Public Utilities Code

~~A strip of submerged land lying in the bed of the American River, Sacramento County, California, located within the Sacramento City limits at the Howe Avenue bridge site, and lying 2.5 feet on each side of the following-described centerline:~~

~~BEGINNING at a point on the north line of that certain Record of Survey entitled, "Portion of Sections 10, 11, 14 and 15, T. 8 N., R. 5 E., M.D.B. & M., recorded in the office of the Recorder of Sacramento County on October 14, 1959, in Book 15 of Surveys, Map No. 2, from which point the northwest corner of said Record of Survey bears S. 70° 31' 20" W. along the northerly line of said Survey, 28.68 feet; thence from said point of beginning N. 00° 23' 45" E., 820 feet more or less to a point on the right or northerly bank of the American River and the end of the herein described centerline.~~

~~EXCEPTING therefrom all lands lying above the ordinary low water mark of the American River as would exist under natural conditions.~~
