

19. EXTENSION OF DREDGING PERMIT P.R.C. 3483.1, SOVEREIGN LANDS OF GALLINAS CREEK, MARIN COUNTY, FOR IMPROVEMENT OF NAVIGATION; COUNTY OF MARIN, DEPARTMENT OF PUBLIC WORKS - W.O. 7223, P.R.C. 3483.1.

APPLICANT: County of Marin, Department of Public Works

## EXISTING PERMIT DATA:

1. Term: 4/28/66 to 12/31/68
2. Dredge area: 3 separate areas in Gallinas Creek, Marin County, totaling 30.3 acres
3. Dredge volume: 208,360 cubic yards
4. Type of land: Sovereign and granted
5. Disposition of dredged material:  
Upon applicant-owned and privately owned lands
6. Purpose: Improvement of navigation
7. Consideration: Royalty assessment of \$0.05/cubic yard

PRESENT REQUEST:

1. Extend permit term to 12/31/69
2. To remove an additional 2,100 cubic yards
3. Deposit all dredged material on privately owned lands

## REASON FOR REQUEST:

To widen a certain portion of Gallinas Creek to allow relocation of a sewer force main

CONSIDERATION: Continuance of royalty assessment
