

### EXHIBIT "A"

A parcel of tide and submerged land lying in the bed of the San Joaquin Riv r and Gallagher Slough adjacent to Sherman Island in the counties of Sacramento and Contra Costa and being more particularly described as follows:

COMMENCING at CSLC triangulation station Shadd - 1953, said station having grid coordinates X = 1,654,974.62 and Y = 566,999.92; thence south 75 feet more or less to a point on the Ordinary High Water Mark of the San Joaquin River, said point being the true point of beginning of this description, said point being also the point of beginning of Oil and Gas Lease P.R.C. 3601.1; thence south along the southwesterly line of said P.R.C. 3601.1, 4200 feet more or less to the Ordinary High Water Mark on the south bank of San Jeaquin River; thence southwesterly along said Ordinary High Water Mark to a point having grid coordinates X = 1,647,700 and Y = 558,000; thence west 2700 feet; thence north 3000 feet more or less to the Ordinary High Water Mark of the north bank of the San Joaquin River; thence northeasterly along the Ordinary High Water Mark to the true point of beginning and containing 926 net acres more or less.

EXCEPTING therefrom all lands on Gallagher or Welga Island lying landward of the Ordinary High Water Mark of the San Joaquin River as it would exist under natural conditions.

The basis of bearings of this description is the California Coordinate System, Zone 3.
