The City of Long Beach, pursuant to the provisions of Section 5(g), Chapter 138/1964, 1st E.S., has requested State Lands Commission approval of the Third Modification of the 1968-69 Plan of Development and Operations and Budget, Long Beach Unit, July 1, 1968, through June 30, 1969, to provide additional funds for injection-water procurement, treating and distribution, and for cellar walkways.

When the 1968-1969 Plan and Budget was drafted early in 1968, the need for the following facilities was not anticipated and therefore no funds were provided therefor:

Requested Budget Increase

1. Purchase and installation of a countercurrent gasstripping facility on Island Bravo to remove oxygen from injection water being made available from the Metropolitan Water District.

\$180,000

2. Installation of a third water-injection pressure system on Island Bravo to increase efficiency of the entire Island Bravo system.

\$ 70,000

3. Installation of a system to receive the fresh injection water on Island Bravo and distribute it to other islands, together with a produced water filtration plant on Pier J and other minor water-injection projects.

\$1.75,000

4. Construction of a walkway in each of the cellars on Island Alfa for the safety of personnel.

\$ 10,000

This proposed Plan and Budget Modification will add the above projects to the Plan and increase the 1968-69 Budget, Part III, A, 2. Field and Well Facilities, by \$435,000.

With approval of this modification, the 1968-69 Plan and Budget, excluding Contingent Liability Items, Warchouse Stock, and Prior Budget Carry-in, will be:
