3. AMENDMENT TO LEASE P.R.C. 3439.1, TIDE AND SUBMERGED LANDS IN THE SAN JOAQUIN RIVER, CONTRA COSTA COUNTY, FOR INSTALLATION OF TWO ADDITIONAL DAY BEACONS; CROWN ZELLERBACH CORPORATION - W.O. N-0365, P.R.C. 3439.1.

After consideration of Calendar Item 9 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

AMENDMENT TO LEASE P.R.C. 3439.1

APPLICANT: Crown Zellerbach Corporation

LOCATION: Tide and submerged lands in the San Joaquin River approximately 1.5 miles east of Antioch, Contra Costa County

LAND USE: The installation of two additional day beacons

TERM OF BASIC LEASE: 5 years, from February 6, 1966

CONSIDERATION: \$100 additional rental for two new beacon sites, \$200 total for the lease

BASIS FOR CONSIDERATION: \$50 per site fixed rental for this type of permit

PREREQUISITE ITEMS: The lessee has applied for a U.S. Army Corps of Engineers permit Applicant is owner of upland
