7. RESCISION OF AUTHORITY TO APPROVE THE ASSIGNMENT OF LEASE P.R.C. 2610.1, SOVEREIGN LAND IN MOKELUMNE RIVER, SACRAMENTO COUNTY, FROM EDWARD C. AND GARTHA L. ZORN TO MARVIN D. AND MYRTLE M. CLARK - W.C. N-0179, P.R.C. 2610.1.

ASSIGNORS: Edward C. and Gartha L. Zorn

ASSIGNEES: Marvin D. and Myrtle M. Clark

LOCATION: A 0.93-acre parcel of sovereign land in Mokelumne River  
3½ miles southeast of Tisleton, Sacramento County

PRESENT USE: Operation of a marina

TERMS OF LEASE: Initial period: 15 years, from August 24, 1960  
Renewal options: 2 additional periods of 10 years each  
Surety bond: \$3000  
Public liability insurance: \$100,000/\$300,000 for personal  
injury

CONSIDERATION: \$150 per annum

## OTHER PERTINENT INFORMATION:

On August 28, 1968 (Minute Item 32, page 978), the Commission authorized approval of the assignment of Lease P.R.C. 2610.1 from the Zorns to the Clarks. The parties to the assignment have since cancelled the transaction. The Zorns remain owners of the upland and the State's lessee.
