

7. AUTHORIZATION TO EXTRACT MATERIAL FROM BED OF SACRAMENTO RIVER IN SOLANO AND SACRAMENTO COUNTIES FOR USE IN CONSTRUCTION OF CALIFORNIA INTERSTATE HIGHWAY 5; DEPARTMENT OF PUBLIC WORKS, DIVISION OF HIGHWAYS - W.O. 7120, P.R.C. 4155.9.

After consideration of Calendar Item 46 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE COMMISSION AUTHORIZES THE APPROVAL, IN ACCORDANCE WITH THE PROVISIONS OF SECTION 101.5 OF THE STREETS AND HIGHWAYS CODE, OF THE MAPS SUBMITTED BY THE DEPARTMENT OF PUBLIC WORKS, DIVISION OF HIGHWAYS, DESCRIBING AN AREA OF SOVEREIGN LANDS IN THE BED OF THE SACRAMENTO RIVER, SACRAMENTO AND SOLANO COUNTIES, FROM WHICH IT IS PROPOSED TO EXTRACT APPROXIMATELY 12,000,000 CUBIC YARDS OF MATERIAL TO BE USED IN THE CONSTRUCTION OF CALIFORNIA INTERSTATE HIGHWAY 5.

APPLICANT: Department of Public Works, Division of Highways

 - a. Department of Fish and Game
 - b. Department of Water Resources
 - c. Water Quality Control Board
4. The State Department of Parks and Recreation has made an examination of the proposed project pursuant to Sec. 6818 of the Public Resources Code, and has no objections
