PROPOSED USE: Grazing

TERM: 10 years, from January 1, 1968

CONSIDERATION: \$83.12 per annum

BASIS FOR CONSIDERATION:

An appraisal by the staff indicates the fair grazing rental to be \$0.01 per acre per year, or, for 8,312.28 acres, an annual rental of \$83.12. The rate per acre is consistent with the carrying capacity and corresponds with the rental rates of similar privately owned lands in the vicinity.
