EXHIBIT "A"

A parcel of submerged land in the bed of Lake Tahoe immediately adjacent to Lot 2, Block 8 of the Cedar Flat Subdivision recorded in Book H of Maps at page 82, Official Records of Placer County, California, said parcel more particularly described as follows:

BEGINNING at the northeast corner of said Lot 2, thence easterly along the easterly projection of the north line of said Lot 2 N. 89° 56' 00" E. to the ordinary low water line; thence easterly, normal to said low water line, 100 feet; thence southerly, parallel with and 100 feet away from said low water line, 130 feet more or less to a point; thence westerly, normal to said low water line, to the point of intersection of the last mentioned line and the easterly projection of the southerly line of said Lot 2; thence westerly along said easterly projection of the southerly line of Lot 2 to the southeast corner of said Lot 2; thence northerly along the easterly line of said Lot 2 N. 08° 05' 20" E. 101.69 feet to the point of beginning.

EXCEPTING THEREFROM any portion lying landward of the ordinary low water line.
