3. PUBLIC AGENCY PERMIT, SUBMERGED LAND, MERCED RIVER NEAR CRESSEY, MERCED COUNTY; COUNTY OF MERCED - W.O. N-0381, P.R.C. 4175.9.

After consideration of Calendar Item 5 attached, and upon motion duly made and carried, the following resolution was adopted:

THE COMMISSION AUTHORIZES THE ISSUANCE TO THE COUNTY OF MERCED OF A 49-YEAR PUBLIC AGENCY PERMIT, FROM FEBRUARY 1, 1969, IN CONSIDERATION OF THE PUBLIC USE AND BENEFIT, FOR CONSTRUCTION OF A BRIDGE ACROSS THE LAND DESCRIBED ON EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF.

PUBLIC AGENCY PERMIT

APPLICANT: County of Merced.

LOCATION: A 0.850-acre (approx.) parcel of submerged land in the bed of the Merced River near Cressey, Merced County.

LAND USE: The construction of a 32' x 300' reinforced concrete box girder bridge.

TERM: 49 years, from February 1, 1969.

CONSIDERATION: No charge (the public use and benefit).

PREREQUISITE ITEM:

Applicant is now acquiring easements on upland.

STATUTORY AND OTHER REFERENCES:

- a. Public Resources Code: Div. 6, Pt. 2, Ch. 1, Secs. 6501-6509.
- b. Administrative Code: Title 2, Div. 3, Secs. 2000-2011.
- c. Commission policy: Minute Item 18 of November 18, 1959.

OTHER PERTINENT INFORMATION:

- 1. The annual rental value of the site is estimated to be \$102.
- 2. A nonmonetary consideration for this permit is justified by governmental responsibility to provide public thoroughfares and bridges for use of the general public.

A parcel of submerged land in the bed of Merced River, Merced County, State of California, situate in Section 8, T. 6 S., R. 12 E., M.D.M., more particularly described as follows:

COMMENCING at the North 1/4 corner, Section 8, Township 6 South, Range 12 East, Mount Diablo Base and Meridian,

Thence, North 89° 27' East, 104.17 feet,  
 Thence, South 15° 39' East, 2,372.98 feet,  
 to the TRUE POINT OF BEGINNING,  
 Thence, North 74° 21' East, 65.00 feet,  
 Thence, South 15° 39' East, 235.77 feet,  
 Thence, North 74° 21' East, 15.00 feet,  
 Thence, South 15° 39' East, 248.32 feet,  
 Thence, South 83° 38' West, 86.12 feet,  
 Thence, North 15° 39' West, 470.20 feet,  
 Thence, North 74° 21' East, 5.00 feet to  
 the point of beginning.
