EXHIBIT "A"

Two parcels of submerged land in the bed of Lake Tahoe, Placer County, California, said parcels being immediately below an existing pier and buoy, said parcels further being described as follows:

PARCEL 1: Being immediately adjacent to the following described land:

Lot 5 of Assessor's Block 252, shown on Assessor's Map Book 86, page 25, TOGETHER WITH the area of necessary use.

EXCEPTING THEREFROM that portion lying above the ordinary low water line.

PARCEL 2: Included within the circumference of a circle having a radius of 10 feet, the center of said circle being a mooring buoy and having a geographic position 100 feet more or less waterward of the ordinary low water line adjacent to above said Lot 5.
