- LOCATION: A 25- x 185-foot (approx.) strip of tide and submerged land in Sevenmile Slough between Owl and Andrus Islands, Sacramento County.
- LAND USE: The construction and operation of a 22 kv power distribution line.

TERM: 49 years, from January 1, 1969.

CONSIDERATION: \$79.20 per annum during first five years, with State reserving the right to review and reset a reasonable rental on each fifth anniversary.
