SEVENTH MODIFICATION OF THE 1968-1969 PLAN OF DEVELOPMENT AND OPERATIONS AND BUDGET, LONG BEACH UNIT, JULY 1, 1968, THROUGH JUNE 30, 1969, WILMINGTON OIL FIELD, LOS ANGELES COUNTY - W.O. 5200.317.

The City of Long Beach, pursuant to the provisions of Section 5(g), Chapter 138/1964, 1st E.S., has requested State Lands Commission approval of the Seventh Modification of the 1968-1969 Plan of Development and Operations and Budget, Long Beach Unit, July 1, 1968, through June 30, 1969.

The proposed modification will provide \$208,000 for the purchase and installation of additional sand media filtering equipment required to process the anticipated ultimate produced water volume on Pier J. The estimated cost for this project is \$208,000.

Also, some minor additions are anticipated to the water-injection systems, which are estimated to cost \$42,000, creating the need for a total of \$250,000 in additional funds.

The proposed modification will change the 1968-1969 Budget as follows:
