3. AMENDMENT OF AUTHORITY TO ISSUE PUBLIC AGENCY PERMIT, SUBMERGED LAND, AMERICAN RIVER, SACRAMENTO COUNTY; SACRAMENTO MUNICIPAL UTILITY DISTRICT - W.O. N-0147, P.R.C. 4156.9.

After consideration of Calendar Item 39 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE COMMISSION AMENDS ITS ACTION OF FEBRUARY 27, 1969 (MINUTE ITEM 8, PAGE 93), WHICH AUTHORIZED ISSUANCE OF A 49-YEAR PUBLIC AGENCY PERMIT TO SACRAMENTO MUNICIPAL UTILITY DISTRICT, P.R.C. 4156.9, TO PROVIDE FOR DELETION OF THE LAND DESCRIPTION CONTAINED THEREIN AND FOR SUBSTITUTION OF THE LAND DESCRIPTION ON EXHIBIT "A" ATTACHED HERETO AND BY REFERENCE MADE A PART HEREOF.

AMENDMENT OF AUTHORITY TO ISSUE PUBLIC AGENCY PERMIT P.R.C. 4156.9

APPLICANT: Sacramento Municipal Utility District.

LOCATION: 1.8 acres of submerged land in the American River, 1000 feet west of the Elvas Freeway, Sacramento County.

LAND USE: The installation and operation of a 230 KV electrical transmission line.

TERM: 49 years, from April 1, 1968.

CONSIDERATION: No charge, pursuant to Sections 10151 and 12808 of the Public Utilities Code. The rental value is estimated to be \$1,620 per annum.

STATUTORY AND OTHER REFERENCES:

OTHER PERTINENT INFORMATION:

By resolution on February 27, 1969 (Minute Item 8, page 93), the Commission authorized issuance of Permit P.R.C. 4156.9 across land which the applicant later determined was inadequately described in their application. This corrects the problem.

EXHIBIT "A"

(Revised)

A parcel of submerged land lying in the bed of the American River adjacent to Section 68, as said section is shown on the "Plat of Survey and Subdivision of Rancho Del Paso" as recorded in the Office of the County Recorder of Sacramento County in Book A of Surveys, Map 94, and being more particularly described as follows:

BEGINNING at the intersection of the east right-of-way line of the Central Pacific Railway Company and the low water line of the north bank of the American River, as said intersection is described in that certain agreement by and between the State of California and Robert Swanston, et al., recorded in said Recorder's office on July 22, 1949, in Book 1677 of Official Records, at page 69, lying east of the east line of said Central Pacific Railway Company; thence from said point of beginning S. 63° 04' 05" W. along said low water line 110.26 feet; thence continuing along said low water line N. 65° 42' 15" W. 52.20 feet to a point on the west line of said Central Pacific Railway Company's right-of-way line; thence continuing N. 65° 42' 15" W. along said low water line a distance of 208.49 feet; thence leaving said low water line N. 81° 13' 20" W. 476.12 feet to a point on the low water line of the north bank of the American River; thence along the low water line the following three courses: (1) S. 70° 37' 47" W. 107.02 feet; (2) N. 88° 07' 11" W. 149.08 feet; and (3) S. 70° 58' 40" W. 3.44 feet; thence leaving said low water line S. 81° 13' 20" E. 1137.62 feet; thence S. 71° 36' 50" E. 447.61 feet to a point on said low water line of the north bank of the American River, as described in said Book 1677 of Official Records, at page 69; thence along said low water line N. 51° 40' 13" W. 99.95 feet; thence N. 64° 43' 25" W. 299.33 feet; thence leaving said low water line N. 71° 36' 50" W. 62.37 feet; thence N. 81° 13' 20" W. 26.41 feet to a point on said low water line; thence along said low water line N. 86° 49' 53" W. 55.11 feet to the point of beginning.

EXCEPTING THEREFROM any land lying above the ordinary low water line.
