10. 5-YEAR NONCOMMERCIAL LEASE, SUBMERGED LAND, LAKE TAHOE, PLACER COUNTY;
TAHOE-MARIN COMPANY - W.O. 5678, P.R.C. 4195.1.

After consideration of Calendar Item 37 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE COMMISSION AUTHORIZES THE ISSUANCE TO TAHOE-MARIN COMPANY OF A 5-YEAR NONCOMMERCIAL LEASE FROM AUGUST 16, 1967, IN CONSIDERATION OF ANNUAL RENT IN THE AMOUNT OF \$156 AND THE PROVISION OF A \$2000 SURETY BOND, TO BE EFFECTIVE UPON EXECUTION ON BEHALF OF THE STATE LANDS COMMISSION, FOR THE CONSTRUCTION AND MAINTENANCE OF A PIER ON THE LAND DESCRIBED ON EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF, WITH LESSEE'S RIGHT TO RENEW FOR THREE ADDITIONAL PERIODS OF TEN YEARS EACH UPON SUCH REASONABLE TERMS AND CONDITIONS AS THE STATE MIGHT IMPOSE.

NONCOMMERCIAL LEASE

APPLICANT: Tahoe-Marin Company, a partnership composed of Rudy L. Tulipani and W. Bruce Shafer.

LOCATION: A 0.098-acre parcel of submerged land in Lake Tahoe near Brockway in Placer County.

PROPOSED USE: The construction of a pier to serve a 25-unit condominium.

TERMS: Initial period: 5 years, from August 16, 1967.
Renewal options: 3 additional periods of 10 years each.
Surety bond: \$2000, to be effective when executed on behalf of State Lands Commission.

CONSIDERATION: \$156 per annum, based on rules and regulations applicable in August 1967.

BASIS FOR CONSIDERATION:
6% of appraised value of land.

PREREQUISITE ITEMS:
U.S. Army Corps of Engineers permit issued.
Applicant is owner of upland.

EXHIBIT "A"

A parcel of submerged land in the bed of Lake Tahoe situate near the community of Brockway, Placer County, California; being more particularly described as follows:

Beginning at a point on the Low Water Mark of Lake Tahoe as said Low Water Mark is shown on sheet 21 of 22 of a map of a "Survey of the Low Water Mark on the Shore of Lake Tahoe" filed as Document No. 7467 in Book 2 of Surveys at page 71, Records of Placer County, which point bears S. 03° 20' W., 3¹/₂ feet more or less and S. 32° 16' 43" E., 634.86 feet more or less from a 1-3/4 inch iron pin located on the most easterly corner of Lot 51, Brockway Vista Subdivision per map entitled "Brockway Vista Subdivision", filed April 6 in Book D of maps at page 16, Records of Placer County, said 1-3/4 inch iron pin having approximately California Zone 2 coordinates of X = 2,561,603.19, Y = 576,819.79; thence from said point of beginning leaving the Low Water Mark S. 57° 38' 42" W., 82.02 feet, S. 32° 21' 18" E., 90.00 feet, N. 57° 38' 42" E., 30.00 feet, N. 32° 21' 18" W., 60.00 feet; thence N. 57° 38' 42" E., 51.99 feet to the above mentioned Low Water Mark, thence along said Low Water Mark N. 32° 16' 43" W., 30.00 feet to the point of beginning; containing 0.093 acre more or less.
