42. PUBLICATION OF NOTICE OF CONSIDERATION, OIL AND GAS LEASE OFFER, 280 ACRES TIDE AND SUBMERGED LANDS IN FALSE RIVER AND PIPER SLOUGH, CONTRA COSTA COUNTY -W.O. 7290.

During consideration of Calendar Item 21 attached, State Senator John A. Nejedly from Contra Costa County appeared to express the concern of the Board of Supervisors of Contra Costa County as to problems that might develop in the area 1.° oil and gas leases should be issued. It was explained that this item was merely a preliminary step, and that before any leases could be offered, public entities would have an opportunity to request a public hearing, at which they could present their viewpoint and raise objections. Senator Nejedly, as well as the Board of Supervisors of Contra Costa County, will be kept informed of any future action on this proposal.

UPON MOTION DULY MADE AND UNANIMOUSLY CARRIED, THE FOLLOWING RESOLUTION WAS ADOPTED:

THE COMMISSION AUTHORIZES THE PUBLICATION OF A NOTICE, AS REQUIRED BY SECTION 6873.2 OF THE FUBLIC RESOURCES CODE, THAT THE COMMISSION INTENDS TO CONSIDER OFFERING A LEASE FOR THE EXTRACTION OF OIL AND GAS FROM AN AREA OF TIDE AND SUBMERGED LANDS DESCRIBED AS FOLLOWS:

TJDE AND SUBMERGED LANDS LYING IN FAISE RIVER ADJACENT TO BRADFORD ISLAND AND WEBB TRACT; AND PIPER SLOUGH ADJACENT TO FRANKS TRACT; SITUATE IN PROJECTED SECTIONS 2, 3, 4 AND 5, T. 2 N., R. 3 E., AND PROJECTED SECTIONS 32, 33, 34, 35 AND 36, T. 3 N., R. 3 E., M.D.B.& M., IN THE COUNTY OF CONTRA COSTA, STATE OF CALIFORNIA; EXCEPTING THEREFROM THAT LAND CONTAINED IN GAS LEASE EASEMENT 415; CONTAINING 280 ACRES MORE OR LESS.
