48. PERMIT TO PROSPECT FOR GEOTHERMAL RESOURCES, PATENTED SCHOOL LAND WITH RESERVED MINERAL INTERESTS, NEAR GEYSERS STEAM FIELD, SONOMA AND LAKE COUNTIES; LAKOMA FAME - W.O. 5981, P.R.C. 4236.2.

After consideration of Calendar Item 41 attached, and upon motion duly made and carried, the following resolution was adopted:

APPLICANT: Lakoma Fame, a California corporation.

LOCATION: Two miles east of Geysers Steam Field, Sonoma and Lake counties.

TYPE OF LAND: Patented school land, reserved mineral interests.

ACREAGE: 1,284.65.

SURFACE OWNER: Applicant.

METHOD OF EXPLORATION: Drilling.
