18. CONSOLIDATION OF PERMITS TO PROSPECT FOR GEOTHERMAL RESOURCES P.R.C. 3395.2 WITH P.R.C. 3473.2 AND P.R.C. 3396.2 WITH P.R.C. 3472.2, GEYSERS AREA, LAKE AND SONOMA COUNTIES; UNION OIL COMPANY OF CALIFORNIA - W.O. 7211, W.O. 7212.

After consideration of Calendar Item 25 attached, and upon motion duly made and carried, the following resolution was adopted:

THE COMMISSION AUTHORIZES THE CONSOLIDATION OF PROSPECTING PERMIT P.R.C. 3395.2 WITH PROSPECTING PERMIT P.R.C. 3473.2 INTO A PERMIT CONTAINING 1,623 ACRES MORE OR LESS AND THE CONSOLIDATION OF PROSPECTING PERMIT P.R.C. 3396.2 WITH PROSPECTING PERMIT P.R.C. 3472.2 INTO A PERMIT CONTAINING 600.43 ACRES MORE OR LESS, ALL ISSUED TO UNION OIL COMPANY OF CALIFORNIA.

OTHER PERTINENT INFORMATION:

The permits were issued on June 13, 1966, to the surface owners under Section 6891 of the Public Resources Code. The permits were assigned to Union Oil Company of California which has requested that the permits be consolidated in order that the permits may be developed more efficiently. Union completed well "Ottoboni State 3396" 1 on Permit P.R.C. 3396.2, and is now drilling "DX State 3395" 1 on Permit P.R.C. 3395.2.

IT IS RECOMMENDED THAT THE COMMISSION AUTHORIZE THE CONSOLIDATION OF PROSPECTING PERMIT P.R.C. 3395.2 WITH PROSPECTING PERMIT P.R.C. 3473.2 INTO A PERMIT CONTAINING 1,623 ACRES MORE OR LESS AND THE CONSOLIDATION OF PROSPECTING PERMIT P.R.C. 3396.2 WITH PROSPECTING PERMIT P.R.C. 3472.2 INTO A PERMIT CONTAINING 600.43 ACRES MORE OR LESS, ALL ISSUED TO UNION OIL COMPANY OF CALIFORNIA.
