20. EXTENSION OF GEOPHYSICAL SURVEY PERMIT P.R.C. 3804.1, MENDOCINO SOUTH THROUGH SAN DIEGO COUNTY; PHILLIPS PETROLEUM COMPANY.

After consideration of Calendar Item 15 attached, and upon motion duly made and carried, the following resolution was adopted:

THE COMMISSION AUTHORIZES THE EXTENSION OF GEOPHYSICAL SURVEY PERMIT P.R.C. 3804.1, ISSUED TO PHILLIPS PETROLEUM COMPANY, FROM JULY 27, 1969, THROUGH JANUARY 26, 1970, UTILIZING THE FORM OF GEOPHYSICAL SURVEY PERMIT APPROVED BY THE COMMISSION ON JULY 17, 1968 (W.O. 7048, MINUTE ITEM 25, PAGE 862), TO SUBSTITUTE FOR GEOPHYSICAL EXPLORATION PERMIT ISSUED UNDER W.O. 6639 ON JULY 27, 1967, AND EXCLUDING THEREFROM LANDS IN MONTEREY BAY.

EXTENSION OF GEOPHYSICAL SURVEY PERMIT  
P.R.C. 3804.1

PERMITTEE: Phillips Petroleum Company.

LOCATION: The offshore area lying between the seaward extension of the northern boundary of Mendocino County and the southern boundary of the State of California, excepting the following-described areas:

- A. San Francisco Bay and other inland waters draining therein;
- B. Lands included in Section 6871.2(1) of the Public Resources Code (Santa Barbara Sanctuary);
- C. Lands lying adjacent to the mainland between a line forming the northwesterly boundary of the City of Newport Beach, Orange County, and the seaward extension thereof, and a line forming the southeasterly boundary of Orange County and the seaward extension thereof;
- D. Lands in Monterey Bay.

METHOD OF EXPLORATION: Seismic.

PRESENT PERMIT EXPIRES: July 26, 1969.

EXTENSION REQUESTED THROUGH:  
January 26, 1970.

OTHER PERTINENT INFORMATION:

On July 17, 1968, under W.O. 7048, the State Lands Commission authorized utilization of a new form of geophysical survey permit for the issuance of any new geophysical permits or extensions of existing permits (Minute Item 25, page 862).
