10. RIGHT-OF-WAY, SUBMERGED LAND IN BED OF GEORGIANA SLOUGH, SACRAMENTO COUNTY, FOR INSTALLATION OF SUBMARINE TELEPHONE CABLES; GENERAL TELEPHONE COMPANY OF CALIFORNIA - W-8494, P.R.C. 4261.9.

RIGHT-OF-WAY

APPLICANT: General Telephone Company of California.

LOCATION: A strip of tide and submerged land, 5 feet wide, lying in the bed of Georgiana Slough, Sacramento County.

LAND USE: The installation of two submarine telephone cables.

CONSIDERATION: Exempt as to duration and consideration by Section 7901, Public Utilities Code.

Being parallel with and located approximately 540 feet northwest (upstream) from the centerline of the Georgiana Slough Bridge, Walnut Grove, California.

To the extent that same shall cross the tide and submerged land of the State of California within the bed of Georgiana Slough.
