23. PERMIT TO DREDGE, SUBMERGED LAND OF LAKE TAHOE AT HOMEWOOD, PLACER COUNTY, FOR CONSTRUCTION OF SMALL CRAFT HARBOR; HELEN T. ALRICH - W-6751, P.R.C. 4287.1.

After consideration of Calendar Item 25 attached, and upon motion duly made and carried, the following resolution was adopted:

THE COMMISSION AUTHORIZES THE ISSUANCE TO HELEN T. ALRICH OF A PERMIT, EFFECTIVE JULY 31, 1969, THROUGH DECEMBER 31, 1970, TO DREDGE 120 CUBIC YARDS OF MATERIAL, AT A ROYALTY RATE OF \$0.10 PER CUBIC YARD, FROM AN AREA OF STATE SUBMERGED LAND IN LAKE TAHOE, PLACER COUNTY, AS DESCRIBED IN EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF.

DREDGING PERMIT

APPLICANT: Helen T. Alrich.

LOCATION: Lake Tahoe at Homewood.

TYPE OF LAND: Submerged land.

PURPOSE: Construction of a small craft harbor.

AMOUNT TO BE DREDGED:
120 cubic yards.

DISPOSITION OF DREDGED MATERIAL:
Spoil areas on applicant's adjacent property.

CONSIDERATION: \$0.10/c.y. royalty.

OTHER PERTINENT INFORMATION:

1. The Department of the Army has issued a permit for the project, effective through December 31, 1970.
2. The State Department of Parks and Recreation has made an examination of the proposed project, pursuant to Section 6818 of the Public Resources Code, and has no adverse comments.

EXHIBIT "A"

Description of Area to be Dredged

All that certain real property situated in Lake Tahoe, Placer County, California, described as follows:

BEGINNING at the most easterly corner of Lot 94, Lakeside Terrace, as the map of said subdivision is shown in Book A of Maps at page 13, Placer County Recorder's Office, thence South $88^{\circ} 56'$ East, 111.14 feet to the TRUE POINT OF BEGINNING of this description, said point being also on the Mean Low Water Line of Lake Tahoe (Bl. 0223): thence North $70^{\circ} 16'$ East, 20 feet \pm ; thence North $19^{\circ} 44'$ West, 85.00 feet; thence South $70^{\circ} 16'$ West, 20 feet \pm ; thence South $19^{\circ} 44'$ East, 85.00 feet to the TRUE POINT OF BEGINNING, and containing .0373 acre of land more or less.
