APPLICANT: Commander, Pacific Missile Range.

LOCATION: Point Mugu, Ventura County.

PROPOSED USE: Two artificial reefs, comprised of steel pontoons, each reef being 14 feet wide and 52 feet long. The reefs are a source of specimens for studies of the Marine Science Division.

TERMS: Initial period: 2 years from August 26, 1969.

CONSIDERATION: The public benefit.

PREREQUISITE TITEMS: U. S. Army Corps of Engineers navigational permit issued. Applicant is owner of upland.
