

12. APPROVAL OF PRODUCTION PLATFORM WITHIN LEASED AREA NEAR RYER ISLAND IN SUISUN BAY, SOLANO COUNTY - W-7386, P.R.C. 3743.1.

After consideration of Calendar Item 30 attached, and upon motion duly made and carried, the following resolution was adopted:

THE COMMISSION AUTHORIZES THE APPROVAL OF THE LOCATION AND CONSTRUCTION, BY STANDARD OIL COMPANY OF CALIFORNIA, OF A TWO-WELL, WOOD-CONSTRUCTED, PILE-SUPPORTED PRODUCING PLATFORM WITHIN THE AREA OF OIL AND GAS LEASE P.R.C. 3743.1, SUBJECT TO THE CONDITION THAT THE LESSEE FURNISH A GOOD AND SUFFICIENT BOND IN THE AMOUNT OF \$20,000 TO GUARANTEE THE FAITHFUL PERFORMANCE BY THE LESSEE OF THE CONSTRUCTION AND MAINTENANCE OF THE PLATFORM AND THE REMOVAL THEREOF AT THE REQUEST OF THE STATE UPON THE EXPIRATION OR SOONER TERMINATION OF THE LEASE, AS REQUIRED BY SECTION 14 OF OIL AND GAS LEASE P.R.C. 3743.1.

PRODUCTION PLATFORM - P.R.C. 3743.1

LESSEE: Standard Oil Company of California and Shell Oil Company.

LOCATION: Within leased area near Ryer Island in Suisun Bay, Solano County.

FIELD: Ryer Island.

DESIGN: Stationary pile-supported production platform of wood construction, capable of servicing two wells.

ENGINEERING REVIEW: Review by staff indicates that the proposed structure is adequate for the service intended. The platform will be substantially the same in design, detail, and appearance as the platform approved by the Commission May 23, 1968 (Minute Item 43, page 608). The production equipment to be located on the proposed platform will be subject to staff review and approval.

OTHER PERTINENT INFORMATION:

Standard Oil Company has drilled and completed well "State 3743" 2 on the lease, and well "Ryer" No. 4 (under Easement Lease P.R.C. 3980.1) on privately owned Ryer Island. The platform will contain facilities for processing gas produced from the two wells.

PREREQUISITE ITEMS:

- a. Application approved by Attorney General's office.
- b. Department of the Army and Bay Conservation and Development Commission permits have been issued.
- c. Pursuant to Section 6818 of the Public Resources Code, a report by the Department of Parks and Recreation states that there are no known recreational activities on littoral lands that would be adversely affected by the permit.
- d. Statutory filing fee (\$25) has been paid.
- e. Bond in the amount of \$20,000 will be submitted by lessee.

IT IS RECOMMENDED THAT THE COMMISSION AUTHORIZE THE APPROVAL OF THE LOCATION AND CONSTRUCTION, BY STANDARD OIL COMPANY OF CALIFORNIA, OF A TWO-WELL, WOOD-CONSTRUCTED, PILE-SUPPORTED PRODUCING PLATFORM WITHIN THE AREA OF OIL AND GAS LEASE P.R.C. 3743.1, SUBJECT TO THE CONDITION THAT THE LESSEE FURNISH A GOOD AND SUFFICIENT BOND IN THE AMOUNT OF \$20,000 TO GUARANTEE THE FAITHFUL PERFORMANCE BY THE LESSEE OF THE CONSTRUCTION AND MAINTENANCE OF THE PLATFORM AND THE REMOVAL THEREOF AT THE REQUEST OF THE STATE UPON THE EXPIRATION OR SOONER TERMINATION OF THE LEASE, AS REQUIRED BY SECTION 14 OF OIL AND GAS LEASE P.R.C. 3743.1.
