42. BOUNDARY LINE AGREEMENT BETWEEN BRUNO AND STELLA GIOVANNONI AND THE STATE OF CALIFORNIA TO ESTABLISH THE ORDINARY HIGH WATER MARK OF OWL ISLAND WITHIN SEVEN MILE SLOUGH, SACRAMENTO COUNTY - N-0252, B.L.A. 114.

After consideration of Calendar Item 43 attached, and upon motion duly made and carried, the following resolution was adopted:

THE COMMISSION:

- (1) APPROVES THE AGREEMENT ESTABLISHING THE FIXED AND PERMANENT ORDINARY HIGH WATER MARK (NOT A MEANDER) OF OWL ISLAND WITHIN SEVEN MILE SLOUGH, SACRAMENTO COUNTY, CALIFORNIA;
- (2) AUTHORIZES A PERMIT AS PART OF SUCH AGREEMENT, NOT TO EXCEED A TERM OF FIFTEEN YEARS, TO DREDGE WITHOUT CHARGE UP TO 16,000 CUBIC YARDS OF MATERIAL FROM THE BED OF SAID SEVEN MILE SLOUGH ADJACENT TO SAID OWL ISLAND;
- (3) AUTHORIZES THE REMOVAL HERETOFORE OF APPROXIMATELY 6000 CUBIC YARDS WITHOUT CHARGE;
- (4) APPROVES AND AUTHORIZES THE RECORDATION OF THE PLAT OF SAID SURVEY OF SAID BOUNDARY AS DESCRIBED IN EXHIBIT "A"; AND
- (5) AUTHORIZES THE EXECUTIVE OFFICER OR ASSISTANT EXECUTIVE OFFICER OF THE COMMISSION TO COMPLETE AND EXECUTE SAID AGREEMENT AND TO EXECUTE SUCH DOCUMENTS AND DO SUCH OTHER ACTS AS MAY BE REASONABLY NECESSARY OR CONVENIENT TO PROVIDE FOR THE COMPLETION, RECORDING AND EFFECTIVENESS THEREOF.

BOUNDARY LINE AGREEMENT BETWEEN BRUNO AND STELLA GIOVANNONI AND THE STATE OF CALIFORNIA TO ESTABLISH THE ORDINARY HIGH WATER MARK OF OWL ISLAND WITHIN SEVEN MILE SLOUGH, SACRAMENTO COUNTY - N-0252, B.L.A. 114.

- (1) Certain land within Seven Mile Slough, Sacramento County, T. 3 N., R. 3 E., M.D.B.& M., was conveyed by the State into private ownership by Swamp and Overflowed Lands Patent, dated March 9, 1875, and recorded in the Office of the Sacramento County Recorder in Book 2 of Patents at page 605 (State Lands Commission Records, S.&O. Patent, Bk. 6, p. 493).
- (2) The applicants, Bruno Giovannoni and Stella Giovannoni, his wife, as joint tenants, claim the land described in said patent and any accretions thereto, except for mineral interests of record, as successors in interest of the patentee.
- (3) The land described in said patent was surveyed by Swamp and Overflowed Lands Survey No. 1062, records of the Commission, and was shown therein to consist of an island within Seven Mile Slough, containing 9.22 acres.
- (4) The patent description contained no tie by which the land described therein can be exactly located.
- (5) The patented land has been determined to be generally located at what is now commonly referred to as "Owl Island".
- (6) The mean high tide line of Owl Island was surveyed by the State Lands Division in 1969.
- (7) The configuration of the lands, as described in the patent and in said 1969 survey of the mean high tide line, does not exactly coincide.
- (8) The nature, extent, and causes of any fluctuation in the boundaries of the patented lands, and the last natural location of the bed of Seven Mile Slough at Owl Island, are the subject of substantial uncertainty and dispute.
- (9) The location of the ordinary high water mark (being the boundary between the lands of applicants (Owl Island) and the tide lands and submerged lands of the State in the bed of Seven Mile Slough) is not known and cannot be established without agreement or court judgment.
- (10) It is expedient and necessary and in the best interests of the parties to fix permanently and to establish the ordinary high water mark, as provided by Section 6357 of the Public Resources Code, without the necessity of litigation, the result of which is uncertain.
- (11) The Division and the applicants have arrived at a mutually acceptable boundary line, as set forth in the attached Exhibit "A". Pursuant to the agreement, Owl Island will contain 9.22 acres, which is the same acreage as that of the original patent.

- (12) As part of the agreement, the applicants desire a permit, not to exceed fifteen years, to dredge, without cost, up to 16,000 cubic yards of material from the bed of Seven Mile Slough adjoining Owl Island, for reclamation of said island. Such dredging will be beneficial to navigation within said slough.
- (13) The Division has executed a survey of the agreed boundaries as described in Exhibit "A', and a plat of such survey will be recorded in the Office of the Sacramento County Recorder.
- (14) Applicants will provide suitable title insurance to the State.
- (15) The agreement will not affect certain oil, gas, and mineral interests of record. The complexities of these interests should not prevent the settlement of the surface rights contemplated by the proposed agreement with applicants.
- (16) The agreement is to be effective upon recordation.
- (17) Applicant has heretofore removed approximately 6000 cubic yards of material from Seven Mile Slough from lands the ownership of which at that time had not been established, and there should be no charge for such material.

IT IS RECOMMENDED THAT THE COMMISSION:

- (1) APPROVE THE AGREEMENT ESTABLISHING THE FIXED AND PERMANENT ORDINARY HIGH WATER MARK (NOT A MEANDER) OF OWL ISLAND WITHIN SEVEN MILE SLOUGH, SACRAMENTO COUNTY, CALLTORNIA;
- AUTHORIZE A PERSIT AS PART OF SUCH AGREEMENT, NOT TO EXCEED A TERM OF FIFTEEN YEARS, TO DREDGE WITHOUT CHARGE UP TO 16,000 CUBIC YARDS OF MATERIAL FROM THE BED OF SAID SEVEN MILE SLOUGH ADJACENT TO SAID OWL ISLAND;
- (3) AUTHORIZE THE REMOVAL HERETOFORE OF APPROXIMATELY 6000 CUBIC YARDS WITHOUT CHARGE;
- (4) APPROVE AND AUTHORIZE THE RECORDATION OF THE PLAT OF SAID SURVEY OF SAID BOUNDARY AS DESCRIBED IN EXHIBIT "A"; AND
- (5) AUTHORIZE THE EXECUTIVE OFFICER OR ASSISTANT EXECUTIVE OFFICER OF THE COMMISSION TO COMPLETE AND EXECUTE SAID AGREEMENT AND TO EXECUTE SUCH DOCUMENTS AND DO SUCH OTHER ACTS AS MAY BE REASONABLY NECESSARY OR CONVENIENT TO PROVIDE FOR THE COMPLETION, RECORDING AND EFFECTIVENESS THEREOF.
