ASSIGNOR: William H. P. Dolan, Jr., as Guardian of the Person and Estate of Marie B. Lloyd.

LOCATION: A parcel of submerged land in the bed of Lake Tahoe, El Dorado County.

LAND USE: The maintenance of an existing pier.

TERMS OF PERMIT: 5 years, from March 1, 1969.
