THE COMMISSION AUTHORIZES ISSUANCE TO THE DEPARTMENT OF PUBLIC WORKS, DIVISION OF HIGHWAYS, OF A PERMIT EFFECTIVE OCTOBER 2, 1969, THROUGH DECEMBER 31, 1972, TO DREDGE 150,000 CUBIC YARDS OF MATERIAL FROM CERTAIN LANDS IN HUMBOLDT BAY, HUMBOLDT COUNTY, AT A ROYALTY RATE OF \$0.05 PER CUBIC YARD, SUCH LANDS BEING DESCRIBED IN EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF.

APPLICANT: Department of Public Works, Division of Highways.

LOCATION: Humboldt Bay at Eureka, Humboldt County.

TYPE OF LAND: Granted tide and submerged, minerals reserved to State.

PURPOSE: Construction of a bridge over Humboldt Bay.

AMOUNT TO BE DREDGED:

150,000 cubic yards.

DISPOSITION OF DREDGED MATERIAL: Fill for bridge construction over Humboldt Bay.

CONSIDERATION: Public benefit and \$0.05 per cubic yard royalty.
