12. PERMIT TO PROSPECT FOR GEOTHERMAL RESOURCES, PATENTED SCHOOL LAND, RESERVED MINERAL INTEREST, NEAR GEYSERS STEAM FIELD, MENDOCINO COUNTY; D. D. FELDMAN, AN INDIVIDUAL - W-5562, P.R.C. 4337.2.

After consideration of Calendar Item 31 attached, and upon motion duly made and carried, the following resolution was adopted:

PURSUANT TO SECTION 6904 OF THE PUBLIC RESOURCES CODE, THE COMMISSION AUTHORIZES THE ISSUANCE OF THE STANDARD FORM OF PERMIT TO D. D. FELDMAN, AN INDIVIDUAL, TO PROSPECT FOR GEOTHERMAL RESOURCES ON LAND IN WHICH THE MINERALS ARE RESERVED TO THE STATE, DESCRIBED IN EXHIBIT "A" ATTACHED AND HEREBY MADE A PART HEREOF. THE PERMIT SHALL CONTAIN THE PROVISIONS IN EXHIBIT "B" ATTACHED AND BY REFERENCE MADE A PART HEREOF.

APPLICANT: D. D. Feldman, an individual.

LOCATION: Ten miles northwest of Geysers Steam Field, Mendocino County.

TYPE OF LAND: Patented school land, reserved mineral interest.

SURFACE OWNER: Pieta Land Company.

METHOD OF EXPLORATION:

THE WEST HALF OF THE WEST HALF ($W\frac{1}{2} W\frac{1}{2}$) AND THE SOUTHEAST QUARTER OF THE SOUTH-
WEST QUARTER ($SE\frac{1}{4} SW\frac{1}{4}$) OF SECTION 15, TOWNSHIP 12 NORTH, RANGE 10 WEST,
M.D.B. & M., MENDOCINO COUNTY, STATE OF CALIFORNIA, CONTAINING 200 ACRES MORE
OR LESS.

EXHIBIT "B"

Nothing in this Permit shall be construed as vesting in the Permittee any right, title, or interest not reserved to the State in that certain Patent issued to John Paul Long on March 22, 1955, and recorded in Mendocino County. Without limiting the generality thereof, the indemnification provisions of paragraph 26 hereof are made expressly applicable to any loss or liability incurred by the State by reason of any incursion upon, damage to, or interference with the right, title or interest of said patentee or any successor in interest to said patentee.
