

15. PERMIT TO PROSPECT FOR GEOTHERMAL RESOURCES, PATENTED SCHOOL LAND, RESERVED MINERAL INTEREST, NEAR GEYSERS STEAM FIELD, SONOMA COUNTY; EUGENE SULLY HANCOCK, JR. - W-5228, P.R.C. 4340.2.

After consideration of Calendar Item 28 attached, and upon motion duly made and carried, the following resolution was adopted:

PURSUANT TO SECTION 6904 OF THE PUBLIC RESOURCES CODE, THE COMMISSION AUTHORIZES THE ISSUANCE OF THE STANDARD FORM OF PERMIT TO EUGENE SULLY HANCOCK, JR., TO PROSPECT FOR GEOTHERMAL RESOURCES ON LOTS 6 AND 7, SECTION 8, AND  $N\frac{1}{2}$  OF  $NW\frac{1}{4}$ , SECTION 17, T. 11 N., R. 8 W., M.D.B. & M., SONOMA COUNTY, CONTAINING 160.22 ACRES MORE OR LESS, IN WHICH THE MINERALS ARE RESERVED TO THE STATE. EXHIBIT "A"

Nothing in this Permit shall be construed as vesting in the Permittee any right, title, or interest not reserved to the State in that certain Patent issued to Willie Domenichelli on November 20, 1953, and recorded in Sonoma County. Without limiting the generality thereof, the indemnification provisions of paragraph 26 hereof are made expressly applicable to any loss or liability incurred by the State by reason of any incursion upon, damage to, or interference with the right, title or interest of said patentee or any successor in interest to said patentee.
