the application. The lands were advertised, stating that bids would be received for all parcels, any one parcel, or any combination of parcels. Great Western Cities, Inc., the only bidder, offered \$57,000 for Parcel No. 1; \$60,000 for Parcel No. 2; \$59,000 for Parcel No. 3; \$64,000 for Parcel No. 4. These bids total \$240,000, which is \$17,480 more than the staff's minimum appraised value.
