

28. PERMIT TO PROSPECT FOR GEOTHERMAL RESOURCES, PATENTED SCHOOL LAND FIVE MILES NORTHWEST OF THE GEYSERS STEAM FIELD, LAKE COUNTY; ORVILLE FORBES AND BILLEE B. FORBES - W-6779, P.R.C. 4396.2.

After consideration of Calendar Item 16 attached, and upon motion duly made and carried, the following resolution was adopted:

PURSUANT TO SECTION 6904 OF THE PUBLIC RESOURCES CODE, THE COMMISSION AUTHORIZES THE ISSUANCE OF THE STANDARD FORM OF PERMIT TO ORVILLE FORBES AND BILLEE B. FORBES TO PROSPECT FOR GEOTHERMAL RESOURCES ON LAND IN WHICH THE MINERALS ARE RESERVED TO THE STATE DESCRIBED AS FOLLOWS:

THE SOUTHWEST QUARTER (SW/4), NORTH HALF OF THE SOUTHEAST QUARTER (N/2 SE/4), THE SOUTH HALF OF THE NORTHEAST QUARTER (S/2 NE/4), THE SOUTH HALF OF NORTHWEST QUARTER (S/2 NW/4) OF SECTION 8, T. 12 N., R. 9 W., M.D.B.& M., LAKE COUNTY, CALIFORNIA, CONTAINING 400 ACRES MORE OR LESS.
