30. PERMIT TO PROSPECT FOR GEOTHERMAL RESOURCES, SUBMERGED LAND, MONO LAKE, MONO COUNTY; GEOTHERMAL RESOURCES INTERNATIONAL, INC. - W-6700, P.R.C. 4398.1.

After consideration of Calendar Item 29 attached, and upon motion duly made and carried, the following resolution was adopted:

APPLICANT: Geothermal Resources International, Inc.  
LOCATION: Mono Lake, Mono County.  
TYPE OF LAND: Submerged land.  
ACREAGE: 2,166.90.  
SURFACE OWNER: State.  
PREREQUISITE ITEMS: a. Application approved by Attorney General's office.  
b. Land has not been classified as known geothermal resources land.  
c. Statutory filing fee and permit fee have been deposited by applicant.
