The proposed Needles Annexation District No. 2 includes tide and submerged lanäs within the Colorado River and, accordingly, pursuant to Section 35014 of the Government Code, the State Lands Commission is required to approve or disapprove the boundaries of the annemation in respect to the included State-owned tide and subraerged lands.

The description of the boundaries has been reviewed by the Division and has been found to be technically sufficient.

The proposed annexation also includes State-owned school lands within Section 36, T. 9 N., R. 22 E., S.B.M., and the staff recommends consent to annexation of said lands pursuant to Government Code Section 35003.
