ASSIGNMENT OF LEASE P.R.C. 2761.1, A NONCOMMERCIAL LEASE

ASSIGNOR: River Enterprises, Inc.

ASSIGNEE: M.C.M. Enterprises, Inc.

LOCATION: A 0.186-acre parcel of tide and submerged land in Sacramento River at Walnut Grove, Sacramento County.

LAND USE: An accommodation dock, formerly serving the recently firedestroyed old Boondox Hotel.

TERMS OF ASSIGNED LEASE:

15 years, from June 1, 1961. Surety bond: \$1,000.

CONSIDERATION: \$150.00 per annum.

STATUTORY AND OTHER REFERENCES:

a. Public Resources Code: Div. 6, Pt. 2, Ch. 1, Secs. 6501-6509.

M.C.M. The Assignee has agreed to provide a replacement bond as required by the lease terms.
