19. MODIFICATION OF COMMISSION ACTION AUTHORIZING ISSUANCE OF PROSPECTING PERMIT P.R.C. 4363.2, SCHOOL LANDS, IMPERIAL COUNTY; CHARLES C. STORIE - W-6947.

After consideration of Calendar Item 26 attached, and upon motion duly made and carried, the following resolution was adopted:

THE COMMISSION AUTHORIZES THE MODIFICATION OF COMMISSION ACTION OF NOVEMBER 14, 1969, MINUTE ITEM 23, P. 1198, DELETING 480 ACRES FROM THE PROPOSED PROSPECTING PERMIT AREA (P.R.C. 4363.2), THUS REDUCING SUCH PERMIT AREA FROM SECTION 36 TO THE SW $\frac{1}{4}$  OF SECTION 36, T. 12 S., R. 20 E., S.B.M., IMPERIAL COUNTY, COMPRISING 160 ACRES. ALL OTHER TERMS AND CONDITIONS OF THE PERMIT ARE TO REMAIN IN FULL FORCE AND EFFECT.

MODIFICATION OF COMMISSION ACTION AUTHORIZING  
ISSUANCE OF PROSPECTING PERMIT P.R.C. 4363.2

PERMIT: Authorized by Commission on November 14, 1969 (Minute Item 23, p. 1198), but not issued.

PERMITTEE: Charles G. Storie.

LOCATION: Imperial County.

MODIFICATION: To change the legal description of the proposed prospecting permit area from Section 36, T. 12 S., R. 20 E. (640 acres), to SW $\frac{1}{4}$ , Section 36, T. 12 S., R. 20 E. (160 acres), Imperial County, deleting the remaining 480 acres.

REQUESTED BY: Permittee.

PURPOSE: To concentrate exploration efforts.
