7. DREDGING FERMIT, GRANTED AND UNENCUMBERED STATE TIDE AND SUBMERGED LAND, OAKLAND INNER HARBOR; PORT OF OAKLAND - W-9187, P.R.C. 4463.9.

After consideration of Calendar Item 27 attached, and upon motion duly made and carried, the following resolution was adopted:

THE COMMISSION AUTHORIZES THE ISSUANCE TO THE PORT OF OAKLAND OF A PERMIT, EFFECTIVE JUNE 25, 1970, TO DECEMBER 31, 1973, TO DREDGE 120,000 CUBIC YARDS OF MATERIAL, WITHOUT PAYMENT OF ROYALTY, FROM AN AREA OF TIDE AND SUBMERGED LAND IN THE OAKLAND INNER HARBOR AS DESCRIBED IN EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF, WITH A PORTION OF THE DREDGED MATERIAL TO BE DEPOSITED ON STATE PROPERTY ADJACENT TO THE DREDGE AREA, AND PORTIONS TO BE DEPOSITED IN APPROVED DUMP SITES NEAR ALCATRAZ ISLAND AND WEST OF THE CITY OF SAN FRANCISCC.

APPLICANT: Port of Oakland.

LOCATION: Oakland Inner Harbor, Alameda County.

TYPE OF LAND: Granted and unencumbered State tide and submerged.

PURPOSE: Laden vessel clearance - ship terminal.

AMOUNT TO EE DREDGED:

120,000 cubic yards.

D / SITION OF DREDGED MATERIAL:

A portion to be returned to State lands near project, and portions to be spoiled at approved dump sites near Alcatraz Island and west of the City of San Francisco.

CONSIDERATION: Commerce development.

OTHER PERTINENT INFORMATION:

- 1. A Department of the Army permit for the proposed project has been issued and is effective to December 31, 1973.
- 2. The San Francisco Bay Conservation and Development commission has issued a permit approving the proposed project.
- 3. The Resources Agency has issued its "State Review and Comment" letter, stating that no adverse comments regarding the proposed work were received from any of the following State agencies:
 - a. Department of Farks and Recreation.
 - b. Department of Fish and Game.
 - c. Department of Water Resources.
 - d. Water Quality Control Board.
- 4. The Department of Parks and Recreation has reviewed the application, pursuant to Section 6818 of the Public Resturces Code, and has verbally approved issuance of the permit.

EXHIBIT "A"

A parcel of submerged land in the bed of the Oakland Inner Harbor formerly known as the San Antonio Estuary, situate in the County of Alameda, State of California, bounded and described as follows:

Bounded on the North by the Ordinary Low Water Mark.

Bounded on the East by a line projected southerly, normal to said Ordinary Low Water Mark from the point of intersection of the easterly line of the Port of Oakland property (2303 O.R. 471) and said Ordinary Low Water Mark.

Bounded on the South by a line defined as the northerly limit of the U.S. Army Corps of Engineers maintained channel.

Bounded on the West by the southerly projection of the easterly right-of-way line of the city street known as Ferro Street.
