THE COMMISSION AUTHORIZES THE OFFERING OF FOUR PARCELS OF LAND UNDER THE JURISDICTION OF THE DEPARTMENT OF CORRECTIONS, SAN BERNARDINO COUNTY, FOR OIL AND GAS LEASE, PURSUANT TO DIVISION 6 OF THE PUBLIC RESOURCES CODE.

THE LEASE AWARD IS TO BE MADE TO THE QUALIFIED BIDDER OFFERING THE HIGHEST CASH-BONUS PAYMENT IN CONSIDERATION OF THE ISSUANCE OF AN OIL AND GAS LEASE.
