6. AUTHORIZATION FOR ISSUANCE OF RIGHT-OF-WAY, SUBMERGED LAND, COLORADO RIVER, SAN BERNARDINO COUNTY; GOLDEN WEST TELEPHONE COMPANY - W-5103, P.R.C. 4481.9.

After consideration of Calendar Item 8 attached, and upon motion duly made and carried, the following resolution was adopted:

THE COMMISSION AUTHORIZES THE ISSUANCE TO GOLDEN WEST TELEPHONE COMPANY OF A RIGHT-OF-WAY FOR AN INDEFINITE PERIOD AND WITH NO MONETARY CONSIDERATION, PURSUANT TO SEC. 7901 OF THE PUBLIC UTILITIES CODE, FOR MAINTENANCE OF AN EXISTING OVERHEAD TELEPHONE CABLE ON THE LAND DESCRIBED ON EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF.

RIGHT-OF-WAY

APPLICANT: Golden West Telephone Company.

LOCATION: A 10- x 500-foot (approx.) strip of submerged land across the Colorado River  $\frac{1}{2}$  miles north of Parker, San Bernardino County.

LAND USE: An overhead telephone cable.

TERM: Indefinite period from June 1, 1967.

CONSIDERATION: Exempt by law.

EXHIBIT "A"

A parcel of land in the bed of the Colorado River, County of San Bernardino, State of California, said parcel being a strip of land 10 feet in width lying 5 feet on each side of the following described centerline:

BEGINNING at the northeast corner of Section 17, T. 2 N., R. 27 E., S.B.M.; thence S. 13° 00' 42" W., 2,842.5 feet; thence S. 04° 59' W., 1,000.00 feet and the end of the herein described centerline.

To the extent that the same shall cross the sovereign lands of the State of California in the bed of the Colorado River.
