20. AUTHORIZATION FOR ISSUANCE OF DREDGING PERMIT, STATE TIDELAND, RAVENSWOOD SLOUGH NEAR PALO ALTO, SAN MATEO COUNTY; BLACKWELL, FERRARI, INC. - W.O. 9035, P.R.C. 4490.1.

After consideration of Calendar Item 14 attached, and upon motion duly made and carried, the following resolution was adopted:

THE COMMISSION AUTHORIZES THE ISSUANCE TO BLACKWELL, FERRARI, INC., OF A PERMIT, EFFECTIVE JANUARY 1, 1970, TO DECEMBER 31, 1971, TO DREDGE 3000 CUBIC YARDS OF MATERIAL, AT A ROYALTY RATE OF \$0.06 PER CUBIC YARD, FROM AN AREA OF STATE TIDELANDS IN SAN MATEO COUNTY AS DESCRIBED ON MAP DESIGNATED AS EXHIBIT "A" ON FILE IN THE OFFICE OF THE COMMISSION AND BY REFERENCE MADE A PART HEREOF, WITH SUCH DREDGED MATERIAL TO BE DEPOSITED UPON ADJACENT PRIVATE PROPERTY.

APPLICATION FOR DREDGING PERMIT

APPLICANT: Blackwell, Ferrari, Inc.
LOCATION: Ravenswood Slough, near Palo Alto.
TYPE OF LAND: State tideland.
PURPOSE: To remove blockage which prevents adequate drainage of applicant's adjacent property.
AMOUNT: 3000 cubic yards.
DISPOSITION: Upon applicant's adjacent property.
CONSIDERATION: \$0.06 per cubic yard royalty.

OTHER PERTINENT INFORMATION:

1. Applicant has submitted the required total royalty of \$180 in full.
2. A department of the Army permit is not required.
3. San Francisco Bay Conservation and Development Commission permit issued August 26, 1969.
4. The Department of Parks and Recreation has reviewed the application pursuant to Section 6818 of the Public Resources Code and states that the proposed work will have no effect on any existing or planned development by that Department.
5. The Department of Fish and Game reports that the removal and spoil operation will not adversely affect fish or wild-life resources.
6. The Department of Water Resources states that the proposed dredging will not adversely affect ground-water resources in the area.
7. The Water Quality Control Board reports that all dredging and construction operations should be performed so as to minimize roiling of the waters and to prevent timbers or floats which may be used in the work from drifting away and becoming a threat to small craft; that if any dredged material is to be deposited as hydraulic fill with discharge from the fill area to waters of the State, the operator responsible for the discharge must report to the Regional Board pursuant to provisions of Resolution No. 68-32; and

that it will be necessary for the applicant to file a written report with that office as soon as possible and at least thirty days prior to the date of award of construction contracts, stating the precautions that he proposes to take during and after construction operations to ensure that the above-stated objectives will be achieved.
