APPROVAL OF THE NINTH AND FINAL MODIFICATION OF THE 1969-1970 PLAN OF DEVELOPMENT AND OPERATIONS AND BUDGET, LONG BEACH UNIT, JULY 1, 1969, THROUGH JUNE 30, 1970, WILMINGTON OIL FIELD, LOS ANGELES COUNTY.

The City of Long Beach, pursuant to the provisions of Section 5 (g), Chapter 138/1964, 1st E.S., has requested approval of the Ninth and Final Modification of the 1969-1970 Plan of Development and Operations and Budget for the Long Beach Unit.

The 1969-1970 Plan and Budget was approved by the Commission at its meeting of April 28, 1969, and subsequently, with Commission approval, was modified eight times. In accordance with Part IV, Section E-2, of the 1969-1970 Plan and Budget, this modification summarizes the work accomplished pursuant to the 1969-1970 Plan and reconciles the funds expended pursuant to the Plan as well as for projects carried-in from the previous Plan and Budget, together with the unexpended investment funds carried forward to the 1970-1971 Budget.

The actual oil production during the 1969-1970 Fiscal Year was less than forecast in the Plan. This lower production has been accompanied by a sharp decline in the oil production rate since the peak rate was reached in August 1969. As a consequence, the commencement of net profit- payments from the tideland tracts has been deferred, with a resulting downward revision of anticipated future State revenue from the Long Beach tidelands.
