26. ADMINISTRATION OF TIDELAND OIL AND GAS REVENUES UNDER PROVISIONS OF PUBLIC RESOURCES CODE SECTION 6817 (CH. 2160, STATS. 1963) FOR FISCAL YEAR 1970-71 - W-4848.

After consideration of Calendar Item 2 attached, and upon motion duly made and carried, the following resolution was adopted:

THE COMMISSION AUTHORIZES, FOR THE 1970-71 FISCAL YEAR, THE REPORTING TO THE STATE CONTROLLER OF THE SUBVENTIONS THAT ARE ATTRIBUTABLE TO THE REVENUES RECEIVED FROM OIL AND GAS LEASES WITHIN THE LIMITS OF QUALIFYING CITIES OR COUNTIES ACCORDING TO THE PARKS AND MILEAGE AS DESCRIBED ON EXHIBIT "A" ATTACHED AND MADE A PART HEREOF.

ADMINISTRATION OF TIDELAND OIL AND GAS REVENUES UNDER PROVISIONS OF PUBLIC RESOURCES CODE SECTION 6817 (CH. 2160, STATS. 1963) FOR FISCAL YEAR 1970-71 - W-4848.

DESCRIPTION: Chapter 2160/63 added Sections 6816.5 and 6817 to the Public Resources Code, providing for subventions of State tide and submerged land oil and gas revenues to cities and counties, under conditions described below, and requiring the State Lands Commission to report to the State Controller the amounts of the revenues to be used for purposes of calculating the subventions.

PURPOSE: To approve qualifying beaches and parks, as required in Public Resources Code Section 6817 (Ch. 2160/63), as enumerated in Exhibit "A" attached.

OTHER PERTINENT INFORMATION:

The salient features of Ch. 2160/63 are:

1. The subventions shall be made to cities or counties that own or operate parks (public beaches) free of charge to the public for recreational purposes, which parks must be offset by tide and submerged land oil and gas leases let by the Commission immediately adjacent to and having a common frontage with the parks.
2. The subvention for each fiscal year shall amount to one per cent of the State's total revenue from leases lying offshore but within the limits of the particular city or county, to a maximum of seventy-five thousand dollars (\$75,000) for each mile or fraction of a mile of ocean frontage of park qualifying under number 1 above.
3. The apportionment for any given fiscal year shall be based upon the physical facts with respect to each city or county existing on June 30 of the preceding fiscal year.
4. The State Lands Commission shall, at the time of remitting revenues to the State Treasury, report to the State Controller the total amount of revenue received from tide and submerged lands shown with respect to each city or county to which such amount is applicable.
5. The legislation provides that "The report of the State Lands Commission and the apportionments of the Controller shall be final".

CALENDAR ITEM 2. (CONTD.)

The Division has investigated all parks and beaches owned or operated by cities and counties to which Ch. 2160/63 might apply for the 1970-71 fiscal year, and has found one change from the previous year. The list of qualifying beaches has been updated to include Port Hueneme Beach Park.

IT IS RECOMMENDED THAT THE COMMISSION AUTHORIZE, FOR THE 1970-71 FISCAL YEAR, THE REPORTING TO THE STATE CONTROLLER OF THE SUBVENTIONS THAT ARE ATTRIBUTABLE TO THE REVENUES RECEIVED FROM OIL AND GAS LEASES WITHIN THE LIMITS OF QUALIFYING CITIES OR COUNTIES ACCORDING TO THE PARKS AND MILEAGE AS DESCRIBED ON EXHIBIT "A" ATTACHED AND MADE A PART HEREOF.
