3. TWELVE-YEAR PUBLIC AGENCY PERMIT, TIDE AND SUBMERGED LAND, SACRAMENTO COUNTY; STATE OF CALIFORNIA, DEPARTMENT OF WATER RESOURCES - W-8812, P.R.C. 4519.9.

After consideration of Calendar Item 7 attached, and upon motion duly made and carried, the following resolution was adopted:

THE COMMISSION AUTHORIZES THE ISSUANCE TO THE DEPARTMENT OF WATER RESOURCES OF A TWELVE-YEAR PUBLIC AGENCY PERMIT FROM OCTOBER 16, 1967, IN CONSIDERATION OF THE PUBLIC USE AND BENEFIT, WITH THE STATE RESERVING THE RIGHT TO SET A MONETARY RENTAL AT ANY TIME IF THE COMMISSION FINDS SUCH ACTION TO BE IN THE STATE'S BEST INTEREST, FOR THE MAINTENANCE OF A FISH-PASSAGE FACILITY ON THE LAND DESCRIBED ON EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF.

PUBLIC AGENCY PERMIT

APPLICANT: Department of Water Resources.

LOCATION: A 0.147-acre parcel of tide and submerged land in the Sacramento River at Ryde, Sacramento County.

LAND USE: The maintenance of a fish-passage facility.

TERMS: 12 years from October 16, 1967.

CONSIDERATION: No charge. The public use and benefit, with the State reserving the right to set a monetary rental at any time if the Commission finds such action to be in the State's best interest.

PREREQUISITE ITEMS:

U. S. Army Corps of Engineers permit issued.  
Applicant is lessee or permittee of upland.

STATUTORY AND OTHER REFERENCES:

- a. Public Resources Code: Div. 6, Parts 1 and 2.
- b. Administrative Code: Title 2, Div. 3, Articles 1 and 2 as amended effective May 10, 1969.

OTHER PERTINENT INFORMATION:

1. The annual rental value of the site is estimated to be \$75.00.
2. This is a replacement of P.R.C. 3287.9, which expired October 15, 1967. Some, but not all, of the lessee's improvements were removed at that time, and this lease will cover the improvements that remained on the site as well as covering the lessee's future operations. The term thereof is designed to coincide with lessee's upland permission expiration.

EXHIBIT "A"

A strip of land 20 feet wide in the bed of the Sacramento River, Sacramento County, lying adjacent to the mean high tide line of the easterly bank of said river and adjacent to and extending northerly 320 feet from an east-west line which intersects the east bank of the Sacramento River at a point which bears S. 21° E., 3,350 feet more or less from U.S.C. & G.S. Triangulation Station "Rydewater Tank 1931", said station having California Zone 3 Coordinates of  $X = 1,695,884.21$ ,  $Y = 634,383.38$ .
