6. 10-YEAR GRAZING LEASE, SCHOOL LANDS, SAN BERNARDINO COUNTY; V. H. UECKERT - W 8914, PRC 4566.2.

After consideration of Calendar Item 3 attached, and upon motion duly made and carried, the following resolution was adopted:

THE COMMISSION:

1. PURSUANT TO SECTION 6371 OF THE PUBLIC RESOURCES CODE, AND IN ACCORDANCE WITH ENVIRONMENTAL IMPACT REPORT NO. 3 ON FILE IN THE OFFICE OF THE STATE LANDS COMMISSION AND BY REFERENCE MADE A PART HEREOF, FINDS THAT A LEASE AS RECOMMENDED HEREIN WILL NOT HAVE A SIGNIFICANT DETRIMENTAL ENVIRONMENTAL EFFECT.
2. AUTHORIZES THE ISSUANCE TO V. H. UECKERT OF A TEN-YEAR GRAZING LEASE FROM NOVEMBER 1, 1970, IN CONSIDERATION OF ANNUAL RENT IN THE AMOUNT OF \$95.38, FOR STOCK GRAZING ON 953.75 ACRES OF LAND IN SECTION 36, T. 18 $\frac{1}{2}$  N., R. 12 E., AND THE S $\frac{1}{2}$  OF SECTION 36, T. 19 N., R. 12 E., S.B.M., SAN BERNARDINO COUNTY.

APPLICANT: V. H. Ueckert.

LOCATION: Section 36, T. 18 $\frac{1}{2}$  N., R. 12 E., and S $\frac{1}{2}$  of Section 36, T. 19 N., R. 12 E., S.B.M., containing 953.75 acres of land in San Bernardino County.

LAND USE: Livestock grazing. (Required environmental impact report is attached.)

TERMS: 10 years, from November 1, 1970.

CONSIDERATION: \$95.38 per annum.

BASIS FOR CONSIDERATION:  
Estimated forage production potential.
