20. DEFERMENT OF OPERATING REQUIREMENTS, MINERAL EXTRACTION LEASE PRC 2094.1, TIDE AND SUBMERGED LANDS, SAN DIEGO BAY, SAN DIEGO COUNTY; SAN DIEGO GAS & ELECTRIC COMPANY - W 9343.

After consideration of Calendar Item 4 attached, and upon motion duly made and carried, the following resolution was adopted:

THE COMMISSION AUTHORIZES THE GRANTING TO THE SAN DIEGO GAS & ELECTRIC COMPANY OF A DEFERMENT OF OPERATING REQUIREMENTS UNDER MINERAL EXTRACTION LEASE PRC 2094.1 FROM MARCH 10, 1970, THROUGH MARCH 9, 1971; ALL OTHER TERMS AND CONDITIONS OF THE LEASE TO REMAIN IN FULL FORCE AND EFFECT.

DEFERMENT OF OPERATING REQUIREMENTS

LEASE: Mineral Extraction Lease PRC 2094.1.

ISSUED: March 10, 1958 (expires March 9, 1978).

LESSEE: San Diego Gas & Electric Company.

LOCATION: Tide and submerged lands, San Diego Bay near City of Chula Vista, San Diego County.

OPERATIONS AUTHORIZED: Extraction of sand, gravel, and fill material.

MINIMUM REQUIREMENTS: 100 shifts of work per lease year.

ACREAGE: 225.78 acres.

ROYALTY: 3 cents per cubic yard.

RENTAL: \$225.78 annually (\$1 per acre).

PRODUCTION TO DATE: 831,997 cubic yards.

PREVIOUS DEFERMENTS: Yearly, from March 10, 1959, through March 9, 1970.

THIS DEFERMENT: From March 10, 1970, through March 9, 1971.

REASON FOR REQUEST: A previously dredged channel provides sufficient cooling water for existing generating units; however, future dredging is anticipated for proposed additional generating units.

IT IS RECOMMENDED THAT THE COMMISSION AUTHORIZE THE GRANTING TO THE SAN DIEGO GAS & ELECTRIC COMPANY OF A DEFERMENT OF OPERATING REQUIREMENTS UNDER MINERAL EXTRACTION LEASE PRC 2094.1 FROM MARCH 10, 1970, THROUGH MARCH 9, 1971; ALL OTHER TERMS AND CONDITIONS OF THE LEASE TO REMAIN IN FULL FORCE AND EFFECT.
