ASSIGNOR: Darrell E. and Lenna V. Grimes  
ASSIGNEE: Kenneth E. and Ursula E. Grimes.  
LOCATION: A 0.7 acre parcel of submerged land in the Sacramento River  
near Meridian, Colusa County.  
LAND USE: A boating facility.

TERMS OF EXISTING LEASE:  
15 years, from August 11, 1958.  
Surety bond: \$1000.

CONSIDERATION OF EXISTING LEASE:  
\$100.00 per annum.

PREREQUISITE ITEMS:  
Applicant is lessee of upland.
