AUTHORIZATION FOR THE OFFICE OF THE ATTORNEY GENERAL TO FILE A DISCLAIMER OF INTEREST OF THE STATE OF CALIFORNIA IN THE CASE OF <u>UNITED STATES V. 436.06 ACRES</u>, <u>YUMA COUNTY, ARIZONA</u>, UNITED STATES DISTRICT COURT (ARIZONA), CASE NO. CIV 6146 PHX - W 503.517D.

On October 24, 1966, the State of California was served in a condemnation action and with an order for delivery of possession of 436.06 acres of land in the County of Yuma, State of Arizona. Investigation by the State Lands Division staff indicated that the land was located east of the centerline of the Colorado River and that no State of California interest existed. On November 23, 1966, staff engineers reported that "All seven parcels are in Arizona and outside of the Stateowned submerged lands. No State of California interest." A second investigation was made by staff on November 30, 1971, and it confirmed that there is no State of California interest in the property involved.

IT IS RECOMMENDED THAT THE STATE LANDS COMMISSION AUTHORIZE THE OFFICE OF THE ATTORNEY GENERAL TO FILE A DISCLAIMER OF INTEREST OF THE STATE OF CALIFORNIA IN THE CASE OF UNITED STATES V. 436.06 ACRES, YUMA COUNTY, ARIZONA, UNITED STATES DISTRICT COURT (ARIZONA), CASE NO.
