9. THREE-YEAR INDUSTRIAL LEASE, BUOY SITES IN GULF OF SANTA CATALINA ADJACENT TO SAN ONOFRE BLUFFS, SAN DIEGO COUNTY; INTERSEA RESEARCH CORPORATION - W 9469, PRC 4648.1.

After consideration of Calendar Item 6 attached, and upon motion duly made and carried, the following resolution was adopted:

THE COMMISSION:

1. FINDS THAT, IN ACCORDANCE WITH ENVIRONMENTAL IMPACT REPORT NO. 38 ON FILE IN THE OFFICE OF THE STATE LANDS COMMISSION AND BY REFERENCE MADE A PART HEREOF, AN INDUSTRIAL LEASE AS RECOMMENDED HEREIN WILL NOT HAVE A SIGNIFICANT DETRIMENTAL ENVIRONMENTAL EFFECT.
2. AUTHORIZES THE ISSUANCE TO INTERSEA RESEARCH CORPORATION OF A 3-YEAR INDUSTRIAL LEASE FROM SEPTEMBER 24, 1971, IN CONSIDERATION OF ANNUAL RENT IN THE AMOUNT OF \$300 AND PROVISION OF A \$1000 SURETY BOND, FOR THE MAINTENANCE OF 12 BUOYS AND STAKES ON THE LAND DESCRIBED ON EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF.

INDUSTRIAL LEASE

APPLICANT: Intersea Research Corporation.

LOCATION: Twelve buoy sites in the Gulf of Santa Catalina, adjacent to San Onofre Bluffs, San Diego County.

LAND USE: 12 buoys and stakes used for an oceanographic monitoring program.

TERMS: Initial period: 3 years, from September 24, 1971.
Surety bond: \$1000.

CONSIDERATION: \$300 per annum.

BASIS FOR CONSIDERATION:
\$300 minimum rental for this type of lease.

PREREQUISITE ITEM:
U.S. Army Corps of Engineers permit issued.

STATUTORY AND OTHER REFERENCES:

- a. Public Resources Code: Division 6, Parts 1 and 2.
- b. Administrative Code: Title 2, Division 3, Articles 1 and 2.

OTHER PERTINENT INFORMATION:

An environmental impact report was prepared and circulated to affected governmental agencies. No adverse comments were received.
