PREREQUISITE ITEMS: U.S. Army Corps of Engineers permit issued for W 20112 on the Sacramento River. W 9508 at So. Laguna is the third renewal of a permit now 11 years old. At the time of original installation, no Corps permit was required. The Corps of Engineers is reviewing their files. The permit will not be executed until the Corps' review is complete and, if required, a Corps permit is issued.

Applicants are littoral landowners as defined in Section 6505, Public Resources Code.

Each applicant has paid the \$25 filing fee.
