17. AUTHORIZATION FOR EXTENSION OF MINERAL EXTRACTION LEASE PRC 4155.9, SACRAMENTO AND SOLANO COUNTIES; DEPARTMENT OF PUBLIC WORKS, DIVISION OF HIGHWAYS - W 9527, PRC 4155.9.

After consideration of Calendar Item 15 attached, and upon motion duly made and carried, the following resolution was adopted:

THE COMMISSION AUTHORIZES THE EXTENSION TO DECEMBER 31, 1974, OF AUTHORIZATION TO EXTRACT MATERIAL, PRC 4155.9, PROVIDING FOR THE REMOVAL OF 12,000,000 CUBIC YARDS OF MATERIAL FROM THE SACRAMENTO RIVER, VICINITY OF RIO VISTA, SACRAMENTO AND SOLANO COUNTIES, BY THE DEPARTMENT OF PUBLIC WORKS, DIVISION OF HIGHWAYS, FOR USE IN STATE FREEWAY CONSTRUCTION, WITH THE REQUIREMENT THAT SUCH DEPARTMENT SHALL DEPOSIT IN THE GENERAL FUND, CREDITED TO THE RESOURCES PROTECTION ACCOUNT, \$0.05 PER CUBIC YARD FOR ALL MATERIAL REMOVED; ALL OTHER TERMS AND CONDITIONS OF THE PERMIT TO REMAIN IN FULL FORCE AND EFFECT.

REQUEST FOR EXTENSION OF AUTHORIZATION TO EXTRACT MATERIAL
(SECTION 101.5 OF THE STREETS AND HIGHWAYS CODE)

PERMIT: PRC 4155.9.

PERMITTEE: Department of Public Works, Division of Highways.

LOCATION: A six-mile stretch of the Sacramento River, vicinity of Rio Vista, Sacramento and Solano Counties.

PURPOSE: For dredging sand and gravel to be used in freeway construction.

ROYALTY REQUIREMENTS: None.

VOLUME AUTHORIZED: 12,000,000 cubic yards.

VOLUME REMOVED TO DATE: None.

EFFECTIVE PERIOD: February 27, 1969, to December 31, 1971.

REQUESTED EXTENSION: To December 31, 1974.

REASON FOR EXTENSION: The need for the material has been delayed; it is now expected to be needed during 1972-73.

OTHER PERTINENT INFORMATION:

1. No environmental impact report is required since permit retained the right to be extended. The permit states that the effective period may be extended upon presentation of an extended Department of the Army permit.
2. The Department of the Army permit was extended, on December 6, 1971, to December 31, 1974.
3. Such extension of the Department of the Army permit was reviewed with no adverse comment by the Resources Agency.
4. In accordance with Chapter 1052, Statutes of 1969, which amends Section 101.5 of the Streets and Highways Code to provide that the Department (of Public Works) shall deposit in the General Fund, credited to the Resources Protection Account, a reasonable value for materials removed from State sovereign lands under such

code section authorization, a charge of \$0.05 per cubic yard for all material removed as agreed to by the Department, is to be included in the proposed dredging permit extension.
