13. AUTHORIZATION FOR EXTENSION OF PERMIT TO PROSPECT FOR GEOTHERMAL RESOURCES PRC 4341.2, PATENTED SCHOOL LAND WITH RESERVED MINERAL INTERESTS, GEYSERS AREA, LAKE COUNTY; UNION OIL COMPANY OF CALIFORNIA - W 9556, PRC 4341.2.

After consideration of Calendar Item 11 attached, and upon motion duly made and carried, the following resolution was adopted:

IN ACCORDANCE WITH SECTION 6910 OF GEOTHERMAL RESOURCES ACT OF 1967, THE COMMISSION AUTHORIZES THE EXTENSION OF PERMIT TO PROSPECT FOR GEOTHERMAL RESOURCES PRC 4341.2, ISSUED TO UNION OIL COMPANY OF CALIFORNIA, FOR A PERIOD OF TWO YEARS OR FROM OCTOBER 2, 1972, THROUGH OCTOBER 1, 1974.

EXTENSION OF A PERMIT TO PROSPECT FOR GEOTHERMAL
RESOURCES PRC 4341.2

PERMITTEE: Union Oil Company of California.

LOCATION: Geysers Area, Lake County.

ACREAGE: 120 acres.

TYPE OF LAND: Patented school land, reserved mineral interests.

EXPIRATION DATE: October 1, 1972.

PREREQUISITE ITEMS:

- a. Application submitted by permittee.
- b. Statutory filing fee paid.

WORK PERFORMED: During the primary three-year term the permittee conducted extensive geophysical exploration in the area, including the drilling of a number of temperature gradient holes in the immediate vicinity of PRC 4341.2 for thermal conductivity studies, and an electrical resistivity survey of the area.

CONSIDERATION: \$120.00 per annum.

OTHER PERTINENT INFORMATION:

Permit to Prospect for Geothermal Resources PRC 4341.2 was issued for the primary three-year term to Eugene Sully Hancock, Jr., an individual, on October 2, 1969. On January 29, 1970, the State Lands Commission authorized approval of the assignment of Permit PRC 4341.2 to Union Oil Company of California. The current permittee requested a two-year extension of the term of said permit for further evaluation of the geophysical data obtained in the area during the primary term.
